Mitigate the Top Dogs

Recorded human history has exposed a small group of people who have been fanatically devoted to preserving & expanding their personal wealth, power, & security. Their willingness to sacrifice any & all ethics, morals, & facts in favor of alternative self-empowering narratives, often including willfully savage realizations, identifies those few people as: "The Top Dogs" (**TD**'s).

Having vilified President Putin & his thus far short war, consider another historical war perspective: The August 2015 National Geographic article: <u>Life After the Bombs</u> (page 106-120). The introduction to the article reads:

"The U.S. dropped more than 2 million tons of bombs on Laos from 1964 to 1973 during the Vietnam War. That's equal to a planeload every 8 minutes for 9 years. How does a country recover?" The article goes on to point out that this was "up to 2000 pounds for every Laotian man, woman, & child".

Ken Burns' 10-part Public Broadcasting System Documentary on the Vietnam War (2017) did a superb job of exposing the labyrinth of American mischief that nurtured & sustained the Vietnam War, including the ancillary bombing of both Laos & Cambodia.

On January 6th 2021 Americans witnessed President Trump on national TV incite his followers to violently prevent certification of the presidential election at the U.S. Capitol. Despite ubiquitous evidence of a wide range of crimes before, during, & after his time in public office, the former president remains unindicted by Attorney General Merrick Garland. Trump continues to de-stabilize our governance both nationally & within individual states. Meanwhile the victims of their orchestrated chaos are distracted and disoriented by disintegrating social events & issues. What many people perceive as history's tragedies become the fortunes of the TD's.

The chaos of contemporary American politics prevents serious consideration of two types of taxes: 1. Taxes on inheritance. & 2. Taxes on rich people. Endless distractions are funded as diversions.
